Board Meeting Minutes

Monday, December 16, 2024, at 7:00 PM Via Zoom Meeting (Meeting ID 307 337 0525/Passcode 388432)

Call to Order – The Lansbrook Master Association Inc. ("LMA") Board Meeting was called to order by President Thiel at 7:00 p.m. Board members Brian Thiel, Ron Schultz, George Fitzgerald, and Scott Tillesen were present.
